

GENERAL TERMS AND CONDITIONS OF CHARITABLE CAMPAIGNS CONDUCTED BY THE OUR HOME IS BULGARIA FOUNDATION

I. GENERAL PROVISIONS

1.1. These General Terms and Conditions govern the use of www.ourhomebulgaria.com (the "Website") in connection with the charity campaigns of the Our Home is Bulgaria Foundation (the "Foundation") organized through the Website.

1.2. Our Home is Bulgaria Foundation, entity number (UIC) 177112437, is a non-profit public benefit organization registered under the Non-Profit Organizations Act. The foundation is based on the idea of promoting the beauty, culture, traditions and history of Bulgaria.

1.3. The Foundation's activities are oriented towards organizing charitable initiatives, as well as campaigns for the renovation and preservation of cultural monuments. To achieve its objects, the Foundation organizes and finances other legally permitted additional business activities, including:

- Raising funds from donors and sources of financial assistance in Bulgaria and elsewhere;
- Negotiating directly with organizations, companies and individuals the specific conditions for the granting of aid, donations, etc.;
- Designing and building the necessary material and technical facilities for the achievement of the Foundation's objects and maintaining the ones already created and provided in Bulgaria;
- Using all legal means to achieve its objects.

1.4. Each visitor to the Website agrees to comply with the provisions of these General Terms and Conditions, which set out the rules of how donations are made to the Foundation by supporters of an initiative ("Donors") via a money transfer ("Donation") using the Website.

II. HOW TO DONATE AND DONATION LIMIT

2.1 Anyone who visits the Website can make a Donation to an initiative organized by the Foundation and described on the Website.

2.2. The Donation amount is determined by the Donor and it may not exceed Euro nine hundred and ninety (EUR 990) or their equivalent in Bulgarian levs regardless of the method of payment chosen.

2.3. Donations are made electronically by completing the form provided in the Initiatives section of the Website and selecting/ticking the "Donate" button.

2.4. In accordance with these General Terms and Conditions when making a Donation, the Donor has the right to choose whether to receive from the Foundation a symbolic Donor recognition sign in the form of a poster or other material promoting the beauty of Bulgaria filmed/produced by the Foundation's team.

2.5. Information about each donation is entered in the Donation and Will Book kept and maintained by the Foundation.

III. PAYMENT METHODS

3.1. The Donor chooses the amount they wish to donate from the form in the Initiatives section of the Website. The Donation can be made either through the Epay platform, www.epay.bg, or directly into the bank account of the Foundation.

3.2. To make a Donation, the Donor provides certain information to the Foundation for identification purposes, including personal data, as follows: full name, personal identification number (or other official personal identification number), e-mail and address (if individuals) and name, UIC (or other identification code), registered office and email address (if legal entities).

3.3. Donations through the www.epay.bg platform are made by the Donor under such terms and conditions as set out by Epay AD on www.epay.bg. The www.epay.bg platform is an electronic payment system accessible through the Epay website and/or through the Epay mobile app. A donation is made by sending the selected sum of money through the payment card of the Donor or through a "micro account" opened in favor of the Donor on www.epay.bg.

3.4. For the Donations, the Foundation does not collect any fees from the Donors (such may be payable by the Donors to www.epay.bg, banks, etc., including conversion fees/costs, depending on the remittance method chosen by the Donor for the Donation).

3.5. In the event that the Donor has chosen to donate via a transfer to the Foundation's bank account, the Donor shall use the Foundation's bank account shown on the Website.

IV. DELIVERY OF A SYMBOLIC DONOR RECOGNITION SIGN

4.1. A symbolic donor recognition sign is sent to Donors who have made a Donation of BGN 50 or their equivalent in Euro or other currency.

4.2. The symbolic donor recognition signs are delivered by courier to the delivery address specified by the Donor, with delivery costs being borne by the Foundation.

V. DATA PROTECTION

5.1. The Foundation takes due care of the protection of Donors' personal data in compliance with the provisions of the Personal Data Protection Act and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) as well as the Privacy Policy approved by the Foundation.

5.2. Subject to the applicable law and the provisions of these General Terms and Conditions, the Foundation shall use the personal data provided by the Donors solely for the purposes of these General Terms and Conditions.

5.3. The Foundation may provide personal data of Donors to third parties, such as online payment providers and couriers, for the purposes of these Terms and Conditions.

5.4. Personal data of Donors can be provided to third parties that are partners of the Foundation, in connection with charitable campaigns and activities related to the objects of the Foundation, only after obtaining Donor's consent.

5.5. The Foundation may use Donors' personal data to send information about other initiatives, to send free newsletters by email or phone, to organize raffles and promotional campaigns, for inquiry, statistical and/or other purposes, upon obtaining Donor's prior consent.

5.6. A request by a data subject to be "forgotten" in connection with a consent given as described above or the exercise of any other right of the data subject shall bind:

- the requesting individual personally in accordance with the Privacy Policy;
- the requesting legal entity only if the request is made by an authorized representative in accordance with the provisions of the Electronic Communications Act.

5.7. A request made by the data subject for suspension of any advertising messages sent to them, to be "forgotten" or to exercise any other right arising from the General Data Protection Regulation should be sent to: e-mail: info@ourhomebulgaria.com, or to the correspondence addresses provided in the Foundation's Privacy Policy and in these Terms and Conditions above. "Data subject" shall be considered any identified or identifiable natural person whose personal data are processed by the Foundation for the purposes set out in these General Terms and Conditions.

VI. INTELLECTUAL PROPERTY

6.1. Donors state that they shall not reproduce in any way, print, electronic or otherwise, any information or materials on the Website or any information or materials provided by the Foundation, and Donors shall not distribute, broadcast, process or use such information and materials, except as permitted by the copyright and related rights laws and by the General Terms and Conditions of the Website.

6.2. Users shall not remove any notice of copyright, trademarks, etc. relating to the protection of intellectual property posted on the Website, on the symbolic donor recognition signs, etc.

6.3. Reproduction of any part of this Website and/or the above said symbolic donor recognition signs is expressly prohibited.

VII. FINAL PROVISIONS

7.1. Limits

It is prohibited to create links to this Website by websites with content that is incompatible with the purposes of this Website or with the Foundation's objects in general, or is contrary to the law and good manners.

7.2. Liability and damages

The Foundation shall not be liable for any damages resulting from the use or downloading of any material or information available on this Website. The use of or reference to any material is the sole responsibility of the users of this Website (including Donors) and they shall be liable for any third party claims against the Foundation made on the basis of unlawful use or abuse of the Website content by users (including Donors). The Foundation reserves the right to claim compensation for any damages suffered and/or compensation paid to any third party resulting from any unlawful acts of users (including Donors) of the Website.

7.3. Representations

The Donor represents and warrants to the Foundation that neither the Donor, nor the natural person or the legal entity controlling or is controlled by the Donor, or is under common control with the Donor, (a) is a person/entity involved in money laundering, terrorist financing or other crimes; and (b) has been convicted of, charged with or investigated for money laundering or terrorist financing.

7.4. Governing law and dispute settlement

The governing law for these General Terms and Conditions shall be the law of the Republic of Bulgaria. All disputes related to the application of these General Terms and Conditions upon or in connection with the Donations made, including disputes arising out of or related to the interpretation, invalidity, performance or termination hereof, as well as disputes as to the filling in of any gaps herein, shall be settled by the competent courts in the Republic of Bulgaria.

7.5. Amendments

The Foundation reserves the right to amend these General Terms and Conditions in order to improve its work, to make changes to the methods of regulation of the relationship with the Website's visitors (including Donors) and to make such other general changes as needed to preserve cause of the Foundation. Users (including Donors) shall be informed of any changes and amendments to the General Terms and Conditions by visiting the Website, where the current and active General Terms and Conditions are published, and they shall abide by them as published.

7.6. Entry into force

These General Terms and Conditions shall enter into force on the date they are published on the Website and shall remain in force until amended or revoked.
